ORDINANCE NO. 08-03

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE TOWN OF NORTH BEACH TO MODIFY THE NORTH BEACH PARKING PLAN.

WHEREAS, the Mayor and Town Council of the Town of North Beach have determined that it would benefit the health, safety and welfare of the citizens of North Beach if certain additional parking restrictions were put in place along Bay Avenue from First Street to Fifth Street, and on Third Street and Fifth Street, up to the limits of the residential parking zone; and

WHEREAS, in order to effectuate the above-mentioned purposes, the Mayor and Town Council will amend Section 108-8 of the Town of North Beach Code which concerns restricted parking zones.

NOW, THEREFORE, IT IS HEREBY ORDAINED by the Mayor and Council of the Town of North Beach that

1. That Section 108-8 (A), Restricted Parking Zones will be amended as follows:

A. There is hereby created within the Town of North Beach a restricted parking zone. This parking zone is shown on the map attached as Exhibit A to this chapter<sup>1</sup>. Exhibit A is hereby made a part of this chapter. This area is bounded by and includes Chesapeake Avenue on the west, Bay Avenue on the east, First Street on the south and Seventh Street on the north. The following restrictions within the restricted parking zone will be effective from May 1 until October 31 every year and will be enforced between the hours of 9:00 a.m. and 1:00 a.m. At all other times of the year and times of the day, the restrictions mandated in this subsection will not apply. As shown on Exhibit A, parking is limited to two hours in any portion of the restricted area except for certain areas where parking is restricted to ½ hour to accommodate high-traffic businesses. The restrictions in this subsection apply to everyone except residents and business owners in the restricted area. Residential parking spaces and signage will be established adjacent to all residential properties within the restricted area. This section does not change the previous designation of residential parking on Chestnut Avenue. In addition to the above, there will be no parking on Bay Avenue from the west side of 8918 Bay Avenue to Fifth Street and the Municipal Parking Lot from 11:00 p.m. to 4:00 a.m. during the months listed above, and there

will be no parking on Third Street on both sides of the streets up to the residential parking zone from 11:00 p.m. to 4:00 a.m. during the months listed above.

AND BE IT FURTHER ORDAINED that upon passage of this Ordinance, the same shall be authenticated by the signature of the Mayor and Town Clerk to be recorded among the Town books kept for that purpose, and that a certified copy of this Ordinance shall be posted and advertised pursuant to Section 19-311 of the Town Charter.

AND BE IT FURTHER ORDAINED that this Ordinance shall become effective on the \_\_\_\_\_ 30<sup>th</sup> day of April, 2008, after being read at two successive Town Council meetings as required by Section 19-311 of the Charter.


